

## Relevant Sections of CCPASR By-Laws

#### ARTICLE VI - OFFICERS AND DUTIES

Section A. The elected officers of the Chapter shall be President, President-Elect, Treasurer, Secretary, and Immediate Past President.

Section H. Any officer who is unwilling or unable to assume and/or perform the duties and responsibilities of the office shall be immediately replaced by a person selected by the Executive Committee. Such a person shall serve until the next meeting of the Chapter where a special election shall be held to elect a replacement for the expired term.

#### **ARTICLE VII - ELECTION OF OFFICERS**

- Section A. The president-elect, treasurer, and secretary shall be elected to two (2) year terms at the Fall meetings in even-numbered years.
- Section C. The terms of office shall begin January 1 of the year following election and end December 31 of the even numbered year following election. Officers shall continue in office until their successors have been elected.
- Section D. The president and vice president shall not be eligible to succeed themselves. The treasurer and secretary may succeed themselves.

#### ARTICLE XII- FUNDS

Section C. In the event the Chapter should dissolve, all assets remaining after the Chapter's bills have been paid shall be transferred to the Pennsylvania Association of School Retirees.


- State PASR will be reaching out to members during June or on your individual anniversary date to remind you of state dues due.
